Officiating: First referee must be a coach. The designated officiating team must provide a second referee, score keeper, score board operator and two line judges. *Failure to provide an officiating crew for your assigned matches will result in a forfeit of the first set of your next match.*

Mandatory Coaches' Meeting: Will be held at 8:40 AM in the main (North) gym.

Schedules: Schedules will be posted on all score tables. Changes will be communicated at the coaches' meeting and throughout the day. Please see program co-directors Tracey Weaver or Janis Goehner for any questions.

Pool play format: 2 sets rally score to 25 pts., win by 2, no cap. . There will be an unlimited service rule with the serve behind the end line. All matches will be played on the lower net using lite volleyballs. Liberos may serve.

Warm-ups: There will be a 10 minute warm-up for match 1 and 2, and 5 minute thereafter. All warm-ups will be shared. Please bring your own warm-up volleyballs.

Playoffs: The 1st and 2nd place teams from each pool will go the Gold Division. The 3rd and 4th place teams will go to the Silver Division. All matches in playoffs are 25, 25, 15 format. Best 2/3, no cap. Playoffs on some courts may begin before pool play is completed on other courts. After your pool is completed, please go to your playoff court. Teams not at the appropriate court, ready to play, may have to forfeit.

Food and Beverages: Concessions will be available. Outside food not permitted. **ABSOLUTELY NO** food or beverages are allowed in the gym. Please use the designated areas and pick up after yourself. Some of the foods that will be sold in the concessions include walking tacos, ham/cheese and turkey/cheese sandwiches, hot dogs, muffins, soft drinks and water.

Admission Fees: Admission for adults are \$5, kids \$2, children 8 and under free..

Directions to Lakeville North High School:

19600 Ipava Avenue, Lakeville MN 55044

Driving Directions:

From southbound Interstate 35: Take the Highway 50 exit. Turn left (southeast) onto Highway 50, and proceed southeast approximately 3 miles on Highway 50 to the stoplight at Ipava Avenue. Turn left on Ipava. The high school is on the right side of the road.

From northbound Interstate 35: Take the Highway 70 exit. Turn right (east) on Highway 70. Turn left (north) on Dodd Blvd. The high school is approximately one mile north, on the left side of the road.

From Cedar Avenue southbound: Turn right on Dodd Blvd. The high school is approximately 3.4 miles ahead on the right side of the road.

From Cedar Avenue northbound: Turn left on 202nd street. Proceed west on 202nd street to either Dodd Blvd or Ipava Avenue. Go north on Dodd Blvd, and the high school will be on your left, or go north on Ipava Avenue, and the high school will be on your right.
